### **Object: Frotet Quarterly Update**

### **Completed Exploration Work**

2025 Winter Drilling

The diamond drilling program conducted this winter at the Regnault Deposit (Figure 2) completed on April 4, 2025, with approximately 22,900 meters drilled. Results from this program will be announced via press release over the coming weeks.

#### **Current Operations**

Frotet Camp

The camp is **currently closed** and is scheduled to reopen later this summer.

### **Upcoming Exploration Work**

2025 Summer Exploration

We are currently planning a potential drilling and surface exploration campaign later this summer. Additional details will be provided as plans progress.

### **Completed Baseline Studies**

Winter 2025

#### **Environmental baseline studies**

Following-up on last year's studies (Figure 3), a ground-based survey targeting large mammals was completed over a two-day period in April around the Regnault deposit. The survey was conducted with the assistance of Wachiih Resources, a local service provider from Mistissini.

#### **Geotechnical Studies**

Packer Testing: exploration drillholes were utilized to measure rock permeability.

*Geochemistry:* Rock samples were evaluated to inform waste pile management and water treatment strategies.

## Decision Regarding Underground Exploration Decline

All baseline studies necessary for permitting & authorization have now been completed. A decision to proceed with the underground exploration decline will be discussed based on the results of the mineral resource estimates and future economic studies.




Figure 1. Frotet Project location






Figure 2. Drilling AOI (Blue Polygon) on the Regnault Deposit




Figure 3. Baseline studies area on the Regnault Deposit.
